

As a piece of evidences (12)

(What if All The 3 Men knew The Truths after a Christmas?)

(2 August 2026)

(Please read them all.)

On 1 August 2026 at around 11:30 am, after the satanic had ordered Almighty or Allah to send his thoughts to provoke Me by telling the information to Me back and forth: "It does not take time until Christmas 2026. Soon, Will is calling You!" "You must wait for Christmas 2026" and "You must wait for Christmas 2027", and I had tried to analyze "If the satanic agreed an agreement with Almighty at the start to allow All The 3 Men to know The Truths "We are fooled into waiting for" after Christmas Day 2026, judges and juries would judge "All The 3 Men truly keep faiths in Jesus, The Judgement (or Repayment Day), and The Bible!" but "If the satanic agreed an agreement with Almighty at the start to allow All The 3 Men to know The Truths "We are fooled into waiting for" after Christmas Day 2027, everyone including the judges and the juries would know "All The 3 Men were under control!", I heard the voice of a woman guiding Me (I am not sure that it was the voice of Ratchaneewan Ad-harn or it was the voice of Nattha Ad-harn, nickname "Tom", the daughter of Ratchaneewan) "วิลอยากให้ศาลตัดสินว่า วิล keep faiths!" or can be translated in The English Language "Will really wants the judges to judge "Prince William keeps faiths in Jesus, The Judgement (or Repayment Day), and The Bible!"

As a result, I could figure one of the demonic plans of the satanic out;

If the satanic agrees an agreement with Almighty at the start to allow All The 3 Men to know The Truths "We are fooled into waiting for" after a Christmas, he plans to **excuse** by **lying to** the foreign people including the judges and the juries at every court of law;

"All The 3 Men really want to tempt everyone into believing "All The 3 Men truly keep faiths in Jesus, The Judgement (or Repayment Day), and The Bible!" but not into knowing "All The 3 Men strongly want much more time to severely torment Angie, Her Parents, and Her Group to suffering die!" and "All The 3 Men strongly want to spend the time while They were pretending to wait for to trick Angie into making excuses for Them before!" so as to trick the judges and the juries into judging "All The 3 Men truly keep faiths in Jesus, The Judgement (or Repayment Day), and The Bible!" and "The Chakri dynasty and all the Thai people are the real felonious leaders!"
