

Other Advices apart from The Advices in The 2 Previous Topics (The perfectly updated version of 6 January 2024)

(Please intentionally read them all.)

Daddy Charles, Will, and Harry, sir. Before all else, I would like You All to know that I am not sure “Request a judge to order something to have a legal result” is called “a plea” or “a petition” but in this document, I am calling it “a plea”. And I would like You All to know;

For Thai civil law;

To request a judge to order something to have a legal result, a person just writes “a plea form” to proceed his request to the judge without reporting anything to a police officer to investigate. So, the person just prepares many things he can find to attach the plea form to help the judge to allow to be as the plea. And he can proceed the plea form to court of law by himself or authorise an attorney to run the process instead of him.

But to sue another person who offended him, he who is a victim has both 2 ways to proceed his court case at a criminal court:

(1) Report his case to a police officer to investigate, and proceed his court case to court of law by himself. And

(2) Report his case to a police officer to investigate. Next, the police officer reports result of the investigation to a state attorney to help the state attorney to have an opinion “sue” or “not sue”. If the state attorney has an opinion “sue”, the state attorney will run process to sue the defendant, and he who is the victim can be “an independent plaintiff” or can request the state attorney to be “a co-plaintiff”.

What he who is the victim has the right to do is up to the kind of the offence.

Daddy Charles, Will, and Harry, sir. **I believe that the laws of Your country and the laws of Thailand are similar. So, to request a judge to order “The marriage of I and the harlot is void” is about “a plea of civil law” with the result that YOU do not need any results of investigation. (You need evidences and witnesses for civil offences such as tort and liability, but You need results of investigation for criminal offences such as offences against life and body, offences against liberty and reputation, and offences against property.) So that, just write a plea form and attach many things I advised You All in the topic “How to request a judge in Your country to order “The marriage of I and the harlot is void” without any investigations?” (The perfectly updated Version of 5 January 2024) to the plea to proceed Your plea to a civil court. And the judge will use his discretion not to “investigate” or to “investigate” at court of law to allow to be as the plea or not to allow to be as the plea 😊😊.**

Daddy Charles, Will, and Harry, sir. I would like You All to know that because while I was writing the topics “How to request a judge in Your country to order “The marriage of I and the harlot is void” without any investigations?” (The perfectly updated version of 5 January 2024) and “The truths Your attorneys have to point a judge to see” (The perfectly updated version of 6 January 2024), I **did not** separate “how to plea at a civil court” from “how to sue at a criminal court”.
