## Systematically, right? (31 August 2025)

I went to Central Department Store Lad Prao branch on 29 August 2025. Before I went to the department store around 4 – 5 days, I had aimed to buy breads at BreadTalk to have lunch on 29 August 2025 because I am bored rice.

On 29 August 2025, before I left My Home, My Mom had given Me money (cash) which She had told Me "4,000.00 THB". The Father Almighty or Allah told Me "Angie, count the cash before". But I trust My Mom, so I did not count the cash.

After I had arrived the department store, I went to YVES ROCHER, and pay 660.00 THB by the cash. (My Mom lent Me Her money paying Her back by installment.)

Next, I went to B2S, and scanned to pay 28.50 THB by My money.

Later on, I went to S&P. I scanned to pay 134.00 THB to continue a membership by My money, and spent 472.00 THB to buy 3 sets of fried rice with crab for My Parents and Nok by the cash.

After that, I went to BreadTalk.

At BreadTalk, it had a paper which was written "cash only". Although I planned to scan a QR code to pay, because My Mom gave Me the cash, so I spent the cash around 300.00 THB to buy breads from BreadTalk.

Then, I went into Tops supermarket to buy products which My Mom had ordered.

However, because My Mom ordered Me to buy many things, so I worried that the cash which My Mom had given Me was not enough to pay because I spent the cash around 1,500.00 THB before. So, I called My Dad to transfer money 4,000.00 THB to My account.

I scanned to pay 2,778.00 THB for Tops supermarket.

Before I left the department store, I had spent the cash around 200.00 THB to buy breads from BreadTalk again.

After I had arrived My Home, I transferred the money 1,222.00 THB to My Dad's bank account, and give the cash 2,360.00 THB back to My Mom.

But another day, My Mom told Me "I gave You the cash 4,500.00 THB!" And "You gave the cash back to Me only 1,860.00 THB!" Whereas, I have Her message in Line Application to prove that She gave Me the cash only 4,000.00 THB. But I do not have any evidences to prove that I gave the cash back to Her 2,360.00 THB except all the receipts from the shops and My Credit.

My Parents made Me scream out loudly and intended not to approach Them!

The Father told Me "Angie, all the Thai people ordered Your Parents to do as if You cheated Them because they strongly want to **tempt** Your Parents into believing "Most of the Thai people are ordered and/or controlled like You" to help them to be able to **alibi** at every court of law"

Did you see that they systematically planned the plan to alibi by lying "We are ordered and/or controlled"?

First, they made My Mom worry of using bank applications on Her mobile phone. So, She spends Her money by cash only. But spending money by cash does not have any slips of transferring to be evidence.

Fourth, they knew that I aimed to buy breads at BreadTalk, so they agreed with BreadTalk to receive only cash at the time I bought. In that they knew that after I had spent the cash at BreadTalk, I would not have enough cash to pay for Tops supermarket. So, I needed to ask My Dad for transferring His money to My bank account.

Just only 4 steps for later ordering My Parents to do as if I cheated Them for the purpose of **tempting** My Parents into believing "Most of the Thai people are ordered and/or controlled like You" to help them to be able to **alibi** at every court of law"!

Systematically, right?

<u>Note</u>: on 31 August 2025 at around 2:30 pm, I went to My Parents' bedroom to take all the receipts to complete total money I spent for BreadTalk by the cash in this topic but I could not find any receipts. The Father told Me "Angie. **They ordered Your Dad to destroy all the receipts!**" ...

... The Father also told Me "Angie. Before they all run this plan, they all had **forgotten** to think about what will happen if You post these truths on You Website!"
