

The Day When I started disseminating compassion on them (1 June 2025)

On 31 May 2025 at around 9:00 am, Ratchaneewan Ad-harn and Ad-harn family allowed Almighty or Allah to tell Me the truths to write the topic “An early group who will be aimed at to kill by his offspring” (31 May 2025) (You can read the topic on My Website.) So, I noted the truths which I heard on a paper to write them after I had lunch.

I had a shower from 11:07 am to 11:40 am. and dressed up from 11:40 am to 12:03 pm. Then, I went downstairs to take My Meal Which were Cooked by My Mom to My Bedroom.

After I had had lunch which were cook-riced, stir-fried Chinese Kale, omelette, and Pepsi (zero sugar) with iced which were the same menu as on 30 May 2025, I tried to sleep but I could not sleep. So, I had Lay’s (Classic) and Pepsi (zero sugar) with iced. Then, I took a rest.

Later on, around nearly 2:00 pm, I started writing the topic. **Before the topic completed, I had quickly figured out distress of king Bhumibol and his family who are satans and devils from the truths I wrote in the topic. I thought that now, they had their own distress because of their own deeds. But I do not want them to continue increasing their own mortal sins more by killing one another. Just confess the truths and surrender to be sentenced as their felonies and crimes. Next, I thought of praying “Compassionate Dissemination” on king Bhumibol, king Vajiralongkorn, the Chakri dynasty, all Thai people, all evil foreign people, their all co-workers, and all evildoers. While I was thinking of disseminating compassion on them, Almighty or Allah underlined the truths to Me many times “Angie, One of Your Holy Missions is to help everyone to see “Law of Karma in this life” (or Jesus calls “Bearing of Fruit in this life”). And a process of law is an important way to complete The Holy Mission!”**

After that, I started typing My Prayer to disseminate compassion on them.

In the period of the time from I started typing The Prayer to around 10:30 pm when I finished typing The Prayer, I sometimes felt very angry because they provoked Me. But I started to think “พวกเธอทำแบบนี้กับเราแล้วพวกเธอมีความสุขใช่ไหม ขอให้พวกเธอมีความสุขมากๆ กับการกระทำแบบนี้กับเรานะ” or can be translated in The English Language “You all did these to Me making you all happy, right? May you all feel so very much happy with the deeds you all did to Me.” And although I was provoked until I felt very angry, I did not want to make them more distressful by scolding them.

After I had finished typing The Prayer, I would brush My Teeth, wash My Face, and apply cream on My Face. And I noticed that My Eyes much sparkled.

I woke My MacBook Pro up from a sleeping mode to disseminate the compassion for everyone at that night at 11:40 pm. Then, I noted the truths to write this topic and went to bed at around 0:30 am. I could not sleep for a moment. But after I had slept, I slept long all the night.

On 1 June 2025, I got up to go to the restroom at around 5:30 am. Next, at around 7:45 am, **I figured out that envious people are also distressful because of their own envy.**

The Day When I started disseminating compassion on them was after **I had dedicated My All Merits especially My All Merits by not eating meats or eating less meats, to every life who is good and who can reform himself both humans and animals and whether he is alive, passed on, or is passed on, including Myself, Will, Our Family, Queen Elizabeth, Prince Philip, Princess Diana, Queen Mom, Our All Ancestors except the mother of My Mom, all gods, all goddesses, and Almighty or Allah 😊😊. (I started dedicating My Merits by not eating meats or eating less meats on 17 March 2025 when was My Mom's Birthday in 2025 😊😊.)**

I do not approach any wicked people and I came to teach "Realists" not to approach any wicked people. So, although I disseminate compassion on them, I will not definitely approach them and will not definitely involve with them except when I proceed Our Court Cases against them. At that time, I involve with them as they are "defendants of felonies, crimes, mortal sins, and sins" which they offended Me and everyone I love.
