

## ***The truths of faculty of law, Thammasat University (29 March 2024)***

A night in the middle of March 2024, while I was thinking about scores of each subject when I studied bachelor degree at Thammasat University, I thought of "LA 450: LABOUR LAW" which My scores were only 66 from 100. After that, I thought of the situation at the time when I just knew the scores. At that time, I wondered "The professors scored Me prejudicially. I could do every article of the exam brilliantly. Why I got only 66 scores from 100 scores?"

Later on, I started really wondering "I could do the exams of many subjects. I answered each article of the exams thoroughly. Why My scores of the subjects were just passed or not good?"

Then, I picked My "official transcript of record" to see. And some situation while I was studying at Thammasat University was occurred in My memory again.

The situation was that after the Thai drug-selling gangs had had problems with Me clearly, "Angel Lek" who is able to contact The Father Almighty, gods, and goddesses, but worked for Special Branch Bureau of the Thai police organization told Me "Kay, don't tell any professors in the university about Your problems with the drug-selling gangs because we do not know who professor else involve with the gangs!"

After My memory had been repeated in My thought many times, The Father Almighty gradually told Me the truths of Me, My scores, and faculty of law, Thammasat University which I admitted in June 1993 and graduated on 13 May 1997. I had read lectures, all books, and all documents which the professor had required until I closed My eyes and contents in the lectures, contents in the books, and contents in the documents appeared in My closed-eyes. I also answered the exam thoroughly. But I got grade D+ for the subject!

It was not enough. I got only grade C+ and C for “EL 171: ENGLISH COURSE 2” and “EL 172: ENGLISH COURSE 3”. And I got grade C for “TU 117: EASTERN CIVILIZATION” which was the subject about memorization. I believed that you know that even though I am nearly 50 years old, how good at memorization I am. So, how about My memorization when I was just 17 years old to 21 years old?

When I studied in 2<sup>nd</sup> semester 1993, “LA 101: JURISTIC ACTS + CONTRACT” was the only one law restricted subject. I remembered that I could remember all articles of civil code of the subject. I also got up at around 3:00 am to read text books and make short-notes. So, after I had passed the examination of the subject, I was sure that I would not fail the subject certainly. Whereas, at the night before the professor would announce scores, I had dreamed that I failed the subject by scores only 52 from 100 (Students of faculty of law, Thammasat University need to make score be equal or more than 60 (from 100) to pass examinations of each subject). And when I saw My scores on a board, I felt like I fell down from a high tower because I failed the subject by the scores 52 from 100!

The Father Almighty told Me “Angie, basically, students who get first class honours and second class honours must not get grade lower than C and must not fail any subjects. Ratchaneewan Ad-harn and Ad-harn family knew Your student ID. They just gave Your student ID: 3601610508 to professors of the university who are their gangsters to make You fail or get not good scores for the exams to make You cannot get any honours, cannot get any scholarships to study abroad, cannot work for any reliable firms, and become “a student who have no future”. So, after You had gotten grade D+ for TU 112 and had failed LA 101, they and their gangsters were sure that You would not get any honours definitely!”

Could you forecast what happened to Me from semester 1994 to semester 1996?

A situation which The Father Almighty told Me reasons and the reasons make Me feel so bad is that “LA 201: WRONGFUL ACTS, UNDUE ENRICHMEN” was a subject in 1<sup>st</sup> semester 1994. For the exam, I got up at around 3:00 am to read text books and make short-notes. So, I could remember all articles in civil code of the subject and all contents of the text books. So that, after I had passed the examination, I was sure that My scores would not lower than 80. But I got only 62 scores from 100 scores!

A peak of the situation was that after the scores of the subject were announced, a student whose name is “Thaweepong Srihong”, nickname “Pae”, whom I used to think that he is My friend asked Me “Kay, how many scores did You get for wrongful acts?” After I had told him “62 scores”, he laughed at Me loudly. At that time, I did not understand his actions.

The Father Almighty told Me in the middle of March 2024, after I had started to know the truths of professors of faculty of law, Thammasat University “Angie, Pae knew that You had full of confidence for the subject. But he also knew that the drug-selling gangs aimed at You as their targets to addict drugs and to suicide. So, Pae laughed at You loudly because he knew what happened with Your scores!”

I will not go into details of each subject because I do not want to remind Myself of what else happened to Me while I was studying at the university anymore. But I would like you to know the truths unthoroughly. From 32 restricted subjects, I have each 24 restricted subjects which I wondered the scores. And from 9 selective subjects, I have each 6 selective subjects which I wondered the scores!

The Father Almighty told Me “Angie, if the professors whom You studied with from 1<sup>st</sup> semester of the university to the last semester of the university judiciously scored You, You would get second class honours by GPA more than 75% certainly! You may wonder “Why did not Angie doubt Her scores while She was studying at the university? Why did Angie doubt Her scores after She had graduated from the university many years?”, so I would like to answer you that after the scores of wrongful acts had been announced not so long, I complained this truth to My senior, nickname “Whane”, “Why I got low scores for subjects which I had had full of confidence that I would get high scores surely?” Then, she answered Me “It is normal for law students. Everything is possible!” And I believed her words!

Whereas, The Father Almighty told Me on 28 March 2024 at night “Angie, while You were studying at the university, I let You wonder Your scores only Labour Law in that it was not Your time to know these truths. But ***now, I would like You and foreign people to know the truths of professors who work for Thai universities to warn You and the foreign people to beware of every word the professors planned to lie to You, so it is the time to declare these truths to everyone!***”

The Father Almighty also told Me on 29 March 2024 at around 1:40 pm “Angie, some truths I let You know when the fittest time comes. I am not sure that now where Prasantaya and Sanpaporn are working for but I met them once in around 2005. At that time, they worked as associates for LAWPLUS (in Association with HERBERT SMITH).
