

Why will you get more evidences? ***(The corrected version of 22 January 2024)***

If you are The Son of The Father Almighty, and you and your family believe ***the lie*** “The God wants us to leave Angie, Her Parents, and Her Group in Thailand until pimp king Bhumibol, pimp king mha Vajiralongkorn, and all Thai people themselves let Angie, Her Parents, and Her Group go in order to know what all Thai people are, and in order to get more (new) evidences to prove their felonies to win court cases”, I would like you all to think over step by step;

1) If you actually have faith in The Father Almighty, ***why do not you believe Words of The Father Almighty after I, The Son, My Parents, and My Group are at the safest place*** “What all Thai people are” “Who Satans, devils, sinners, and wicked people are” “What they planned to do” “What they have done” and “What they would do if they had a chance to live in the new better world”?
