Both conventions provide for the establishment The two offices were merged in 1893 and in 1970 were replaced by the World Intellectual Property Organization. By virtue of the WIPO Convention and Thailand became a party on 13 July 2022. The WCT Treaty has important content regarding the protection of copyright works in the digital environment. Currently, the WCT has a total of 113 countries as parties. The Marrakesh Treaty, the Madrid Protocol, the PCT Paris Convention deal with the protection of industrial property, and the Berne Convention deal with the protection of copyrighted works. The Berne Convention currently has a total of 177 countries party to it. (Copyright in unpatented literature referenced by international search agencies) which provides protection to third parties, meaning the inventor and beneficiary from the invention by swearing that this invention is ours and we will protect it all over the world, by World Intellectual Property Organization: WIPO by Creative Literature Fire extinguishing ball, International Publication No. WO 2004/014489 Date 19 FEB 2004 and Creative Literature Fire extinguishing ball 2 published by International Publication No. WO 2008/150265 Date 11 DEC 2008 created by Mr. Woradech Kaimart and now changed his name to Mr. Phanawatnan Kaimart is still alive and protected by the Bern Convention empowering countries to allow the use of copyrighted works. in a fair manner subject to the exceptions to infringement under Section 9 (2). This is consistent with Article 13 of the TRIPs Treaty. It must be in accordance with the objectives specified by law.
